Meeting called to order at 7:01pm by Chairman Sisk

APPROVAL OF MINUTES

Committee Member Calhoun moved to approve the minutes from the September 30, 2014 meeting. Seconded by Committee Member McEvoy. All committee members present voted aye. Motion carried.

CHAIRMAN'S REPORT – Chairperson Sisk thanked the committee for their help with Celebration in the Park.

NEW BUSINESS – There was no new business discussed.

OLD BUSINESS – Chairperson Sisk reported the revenues and expenses derived from Celebration in the Park. The committee reviewed the programs that worked well and what they would like incorporated next year. They discussed the time of the year the event is held and agreed to continue having it on the first Saturday of October.

Chairperson Sisk asked the committee their preference on when to hold Holiday Magic. They agreed to have it the first weekend in December. Committee Member McEvoy inquired about Holiday Magic hours and if the Men's Club can participate. The committee discussed having it from 6:00pm to 8:00pm. They also discussed the details of the event.

Committee Member McEvoy asked when a good day would be to have an open skate at the ice rink. The committee discussed details of the event. Committee Member Calhoun stated that he was able to purchase the liner for two years. He stated that it saved the village money to purchase a liner that was large enough to be cut in half for two years rather than purchase the actual size liner each year.

Chairperson Sisk inquired about the Easter Egg Hunt. Committee Member McEvoy stated that the 2015 event will be on April 4th. The committee discussed the details of the Easter Egg hunt and made recommendations based on the large attendance of last year's hunt.

Committee Member O'Brien asked if it would be possible to obtain a laminated aerial view map of the parks so that they can plan events appropriately.

Committee Member Calhoun inquired about the sports organization meeting. Chairperson Sisk stated she would be contacting the organizations to have a meeting before the end of the month. Committee Member Calhoun also stated that there have been inquiries into selling advertising space. Chairperson Sisk mentioned that as a committee they have discussed it but would have to check further into it.

Committee Member McEvoy inquired about the basketball court at Hiller Park. She stated that funds had been allocated for it. Chairperson Sisk will check into it.
