**APPROVAL OF MINUTES**

**NEW BUSINESS** – There was no new business discussed.

**OLD BUSINESS**

Chairperson Sisk stated that she will check to see if funds have already been allocated for the project and find out if public works can perform the grading for the court.

Sport's Organization Meeting - Chairperson Sisk informed the committee of the meeting that took place with representatives of the local sports organizations. Committee member Calhoun discussed the sharing of fields both at the High School and Hiller Park. Chairperson Sisk stated that she discussed the access to the parks with the school's superintendent, Dan Johnson.

Holiday Magic - Committee Member McEvoy informed the committee that Justin Griletz prepared the flyers for Holiday Magic. She then reviewed the schedule for the event. Committee Member O'Brien shared his plans for taking pictures of the children with Santa. Committee Member McEvoy discussed the details for the food, decorations and time for set up.
