

## **Village Board Report – December 2014**

*Welcome to the Village Board Report which is placed on our website monthly to keep you informed of actions taken by the Village Board on ordinances and other significant matters.*

**Property Casualty/General Liability/Worker's Compensation Insurance** – At the December 2, 2014 meeting the board accepted the proposal from Arthur J. Gallagher Risk Management Services, Inc in the amount of \$105,758 for the Village's Property Casualty, General Liability and Worker's Compensation insurance.

**Tax Levy/Elimination of Vehicle Stickers** - At the December 2, 2014 meeting, the Village Board approved a tax levy which captures new growth and incorporates a 1.5% CPI increase.
