

Village Board Report – December 2015

Welcome to the Village Board Report which is placed on our website monthly to keep you informed of actions taken by the Village Board on ordinances and other significant matters.

Property Casualty/General Liability/Worker's Compensation Insurance – At the December 1, 2015 meeting the board accepted the proposal from Arthur J. Gallagher Risk Management Services, Inc in the amount of \$105,023 for the Village's Property Casualty, General Liability and Worker's Compensation insurance.

Tax Levy - At the December 1, 2015 meeting, the Village Board approved a tax levy which captures new growth and no increase for existing properties.

SSA #32 Sewer Improvement Project/Sunnyside Beach – At the December 22, 2015 a public hearing was held before the Village Board regarding the proposed Special Service Area #32 for a wastewater treatment and collection system project on Sunnyside Beach Drive. The hearing closed that same night, thus starting the 60 day objection period.

December 1, 2015 Ordinances - At the December 1, 2015 meeting, the Village Board approved the following ordinances:

- Ordinance 15-16-20 Establishing a Tax Levy for Special Service Area #6 in the Village of Johnsburg for the 2015 Tax Year
- Ordinance 15-16-21 Establishing a Tax Levy for Special Service Area #11 in the Village of Johnsburg for the 2015 Tax Year
- Ordinance 15-16-22 Establishing a Tax Levy for Special Service Area #13 in the Village of Johnsburg for the 2015 Tax Year
- Ordinance 15-16-23 Establishing a Tax Levy for Special Service Area #18 in the Village of Johnsburg for the 2015 Tax Year.
