

Village Board Report – June 2016

Welcome to the Village Board Report which is placed on our website monthly to keep you informed of actions taken by the Village Board on ordinances and other significant matters.

SALES TAX – At the June 7, 2016 meeting, the Board discussed how new revenues resulting from the Sales Tax Referendum should be directed to insure that underfunded capital expenses are supported and the community's needs are met.

SSA 32 – SUNNYSIDE BEACH -At the June 7, 2016 meeting the Board accepted Authorization of Engagement letters from Bernardi Securities and Ice Miller, LLP for Bond Underwriter and Bond/Disclosure Counsel services related to SSA 32. At the June 21, 2016 meeting the Board entered into an Agreement with Taussig and Associates for SSA 32 accounting related services.

CHURCH STREET STREETScape – At the June 7, 2016 meeting the Board approved an application for ITEP Funding to support streetscape enhancement for the Church Street Road Improvement Project.

INTERGOVERNMENTAL AGREEMENT – At the June 21, 2016 meeting the Board entered into an Intergovernmental Agreement with McHenry County, the City of McHenry and the Village of Lakemoor related to the jurisdictional authority of Old Bay Road. Additionally, the board approved an amended version of an Intergovernmental Agreement with McHenry County, the City of McHenry and the Village of Lakemoor regarding boat launch rights and use. At a special meeting held on June 28, 2016, the board reconsidered the amended Intergovernmental Agreement regarding boat launch rights and approved it in its original form.

Ordinances – The Board approved the following ordinance at the June 7, 2016 meeting:

- Move to approve Ordinance 16-17-06 Granting a Variance to the property commonly known as the Franz property 2201 Fairview Avenue
- Move to approve Ordinance 16-17-07 Granting a Special Use Permit to the property commonly known as Wantuch Property 3315 Johnsburg Road.
- Move to approve Ordinance 16-17-09 Establishing the Prevailing Wage Rate for the Village of Johnsburg.

Ordinances – The Board approved the following ordinances at the June 21, 2016 meeting:

- Move to approve Ordinance 16-17-08 Granting a Special Use Permit to the property commonly known as 2420 Johnsburg Road.
- Move to approve Ordinance 16-17-11 Authorizing the Borrowing of Funds for the General Municipal Corporate Purposes of the Village of Johnsburg, County of McHenry, State of Illinois.

- Move to approve Ordinance 16-17-10 Providing for the Issuance of not to Exceed \$750,000 Village of Johnsburg Special Service Area Number 32, Special Tax Bonds, Series 2016 and Providing for the Levy of a Direct Annual Tax on Taxable Property in Such Special Service Area for the Payment of Principal of and Interest on Such Bonds.
- Move to approve Ordinance 16-17-12 Amending Chapter 9 of the Johnsburg Municipal Code
