AUDIENCE PARTICIPATION – Frank Lorch attended to express concerns regarding the condition of Chapel Hill Golf Course. He questioned if there was something that could be done to get the course back in shape. President Hettermann concurred that the course needs some attention and discussed the improvements that the Village has pursued since its acquisition. He added that Village staff meets with the course's manager every six weeks to discuss concerns that need to be addressed. President Hettermann explained that the main irrigation well was not functioning during the drought which contributed to the problems but has since been repaired and the Village is looking into activating another well. Assistant Administrator Lamontagna stated that the lack of irrigation was discussed at the last meeting along with the T-boxes and weeds.

**COMMITTEE REPORTS** - Trustee Foreman reported that 114 tickets have been sold to date for the Party in the Burg event. Trustee Frost requested additional tickets. Assistant Administrator Lamontagna reported that a total of 200 tickets were ordered to sell.
