**TAX LEVY RESOLUTION** - Trustee Klemstein moved to approve the Tax Levy Resolution. Trustee Foremann seconded the motion. Trustee Curry questioned if the estimated levy includes new growth. Ms. Sofiakis confirmed that it reflects the CPI and new growth.

**PRESIDENT'S REPORT** - President Hettermann sought confirmation regarding the preferred meeting date in December. All Trustees confirmed their attendance for December 6<sup>th</sup>.

### **NEW BUSINESS**

**ORDINANCE 22-23-11** – The Board performed a first read of Ordinance 22-23-11 amending sections of the Municipal Code related to parking in the Village. Trustee Frost explained that the Ordinance Committee recommended changes to the Code to regulate parking in front yards as several instances have been observed in which residents are regularly parking in the front yard as they have many vehicles in the driveway an no room to park in their garage. He added that the Committeee realizes in cases of special events or driveway repairs, temporary parking in the front yard may be necessary and therefore proposed language to accommodate those instances. Trustee Hagen expressed concern with limiting the occurrences to six per year and requiring prior notification to the police department. Trustee Frost explained that the number of times annually is a suggestion and can be changed if the board desires. Ms. Sofiakis explained that the prior notification to the police department is consistent with current ordinances that requires prior notification when overnight parking in the street is needed. President Hettermann explained that in most cases front yard parking is not problematic but the Ordinance provides a tool to enforce situations when continuous parking in the front yard takes place. Trustee Curry questioned language regarding the parking of commercial vehicles in driveways. Ms. Sofiakis suggested that language be added consistent with other sections of the Code related to commercial vehicles. The matter will be included on the next agenda for consideration.

#### **OLD BUSINESS**

**HOLIDAY MAGIC** - Trustee Foreman discussed the proposed parade route and details for Holiday Magic.

**ADJOURNMENT** – Trustee Frost moved to adjourn the meeting. Trustee Hagen seconded the motion. All Trustees voted aye. Motion to adjourn was carried at 7:25 p.m.
