**ORDINANCE 23-24-05 AMENDING CHAPTER 3** - Trustee Hagen moved to approve Ordinance 23-24-05 Amending Chapter 3 of the Johnsburg Municipal Code. Trustee Letzter seconded the motion. Trustee Hagen questioned if the Village Board's pay is considered a salary and if so can the pay be predicated upon meeting attendance. Attorney Smoron stated that the proposed amendment is allowable per the Illinois Municipal Code. Further discussion occurred regarding instances of illness preventing attendance at meetings.
