LOCAL DEBT RECOVERY PROGRAM - Trustee Fouke moved to approve an Intergovernmental Agreement by and between the Illinois Office of the Comptroller and the Village of Johnsburg regarding Access to the Comptroller's Local Debt Recovery Program.
