## Village Board Report – December 2013

Welcome to the Village Board Report which is placed on our website monthly to keep you informed of actions taken by the Village Board on ordinances and other significant matters.

<u>Ice Rink</u> – At the December 5, 2013 meeting the Village Board authorized the pursuit of an ice skating rink at Rescue Squad Memorial Park (adjacent to the Johnsburg Community Club grounds).

<u>Tax Levy/Elimination of Vehicle Stickers</u> - At the December 16, 2013 meeting, the Village Board approved a tax levy which captures new growth and incorporates a 1.7% CPI increase. In conjunction with the levy approval, the board reached a consensus to eliminate vehicle stickers beginning next fiscal year.

<u>Property Casualty/General Liability/Worker's Compensation Insurance</u> – At the December 16, 2013 meeting the board accepted the proposal from Arthur J. Gallagher Risk Management Services, Inc in the amount of \$98,950 for the Village's Property Casualty, General Liability and Worker's Compensation insurance.
